Introduction

Dear Readers,

From the beginning of October to the end of December 2022, **162 618** new names were registered, which was by **7 299** more than in the previous quarter. At the end of the quarter closing the year, **2 510 256** names were maintained in the .pl domain registry, i.e. almost 17 thousand fewer than at the end of the third quarter. **3 839** fewer names were renewed than in the previous quarter. The renewal rate decreased by 0.79 p.p. and stood at **73.16%**.

Compared to the previous quarter, the number of renewed agreements on options for registration of a .pl domain name more than doubled in the discussed period and amounted to **1 574**. This is the highest number of renewals of this service since 2011, i.e. since the introduction of renewals of options.

On **18 December 2022, 20 years** have passed since launching the NASK Partner Programme. At the end of December, **196** Partners from **23** countries were participating in it; **125** from Poland, **48** from other European countries, and **23** from outside Europe. 


Domains in .pl domain registry


At the end of 2022 in the .pl domain registry, **2 510 256** names, active in DNS, were maintained, which is **16 679** fewer than in the previous quarter.

At the end of the fourth quarter, the number of names, active in DNS, maintained directly in the .pl domain amounted to $2\,041\,076$. The number of names in functional domains amounted to $376\,735$, and in regional domains $-\,92\,445$.


Transfers

From the beginning of October to the end of December 2022, **42 882** transfers of .pl domain name service were carried out, **466** daily average.


In **2 292** cases, transfers were executed with simultaneous renewal of a .pl domain name for a consecutive billing period, whereby **620** were effected after the previous billing period had been completed.


Renewal of a domain name for a consecutive billing period

At the end of the fourth quarter of 2022, the renewal rate amounted to **73.16%**. It decreased by **0.79 p.p.** compared to the previous quarter.


In the discussed period, **451 333** names were renewed. and for **1 814** names the end of the billing period was shifted by an individually defined number of days.




Renewal rate of .pl domain names



Number of renewed .pl domain names




Structure of renewed .pl domain names, Q4 2022





During the fourth quarter of 2022, there were released **170 725** names from the .pl domain registry due to lack of renewal for a consecutive billing period by registrants.

Whereas, **24 735** names were deleted from the registry by a proper EPP request.

New names in the .pl domain registry


In the last three months of 2022, **162 618** .pl domain names were registered, over **7 thousand** more than in the preceding quarter.

The number of registrations in particular months amounted to: **53 741** in October, **54 659** in November, **54 218** in December.


138 555 names were registered directly in the .pl domain, **19 701** names in functional domains, and **4 362** names in regional domains.




Number of .pl domain name registrations

Registrants in the .pl domain registry

At the end of December 2022, the .pl domain registry had **1 112 349** unique registrants, of which **35.47%** were natural persons and **64.53%** were organizations.

In the fourth quarter of 2022, **6 653** entries regarding registrants were removed from the registry.






Number of changes of .pl domain name registrants, Q4 2022




Division of Registrants of .pl domain names, Q4 2022



.pl domain names, active in DNS, as divided into the type of a registrant, Q4 2022




Division of .pl domain name registrations for the type of registrant, Q4 2022


Place of residence of .pl domain name registrants




Additional services of .pl domain registry DNSSEC

At the end of the fourth quarter of 2022, in the .pl domain registry, there were **440 360** names secured with the DNSSEC protocol, with **32.48%** thereof being registered in 2022, **13.87%** in 2021, **7.27%** in 2020, **19.44%** between 2019 and 2016, **16.68%** between 2015 and 2010, while remining **10.26%** between 2009 and 1994.


Additional services of .pl domain registry

At the end of December 2022, names with national diacritic signs (IDN) constituted **1.10%** of all .pl domain names, active in DNS, and their number amounted to **27 610**.


In the fourth quarter of 2022 **1938** IDNs were registered, which constituted **1.19%** of all .pl domain names registered during that period.

Options

In the last three months of 2022, **4 173** agreements on option for registration of a .pl domain name were concluded, and **1 574** were renewed for a consecutive 3-year period. The number of option agreements concluded in each month of the fourth quarter of 2022 was: **3 041** in October, **561** in November and **571** in December.

1 153 existing option agreements were completed with a domain name being provided for registration. In **67** cases, registration did not take place for reasons attributable to the option holder, resulting in names being released for public registration.

Number of WLS registrations





NASK Partner Programme

At the end of December 2022, in the NASK Partner Programme, there were participating **196** registrars from **23** countries.

125 registrars, servicing totally over **1.61 million** .pl domain names, had their registered offices in Poland, **48** registrars, seated in other European countries, were handling nearly **532 thousand** .pl domain names, whereas **23** registrars from outside of Europe, were operating nearly **369 thousand** .pl domain names.


Division of Partners for their place of residence, Q4 2022








Division of .pl domain names for Partner's registered office, Q4 2022
